PLEASE TAKE NOTICE that the Brady Township Zoning Board of Appeals has scheduled a Public Hearing / Meeting for **Tuesday, August 17, 2010, 7:00 p.m.** at the Brady Township Hall, located at 13123 N. Richardson (South 24th) in the Township of Brady, Kalamazoo County, Michigan.

The purpose of this hearing/meeting is to address a request for a Variance for land located within the Township of Brady as follows:

1. Ronald & Sharron Butler, of 11925 W. Indian Lake Dr., in Vicksburg, MI have requested a variance for a kennel license for a current kennel on land that they own at the above address, in Brady Township, Vicksburg, MI (05-380-017, 05-300-012, 13, 14, & 17). This request may also involve variances from other zoning requirements, as may be determined based on the facts presented at the public hearing. (2010V03)
2. Melissa Bacon, of 9565 E. YZ Ave, in Vicksburg, MI, has requested a variance for the relief of front setbacks for an addition of a porch on the front of an existing dwelling on land that she owns at the above address, in Brady Township, Vicksburg, MI (35-200-020). This request may also involve variances from other zoning requirements, as may be determined based on the facts presented at the public hearing. (2010V04)

Such other and further matters as may properly come before the Board. The Brady Township Zoning Ordinance and the applications for this matter may be examined by contacting the Township Offices. Written comments regarding this matter may be submitted at the Township Hall prior to this public hearing/meeting and may further be submitted to the Zoning Board of Appeals at the public hearing/meeting.

Brady Township will provide necessary reasonable auxiliary aids and services at the meeting/hearing to individuals with disabilities, such as signers for the hearing impaired and audiotapes of printed materials being considered, upon reasonable notice to the Township.
